

**FIRST AMENDMENT TO  
STUDENT CLINICAL PLACEMENT AGREEMENT**

This **FIRST AMENDMENT TO STUDENT CLINICAL PLACEMENT AGREEMENT** (“Amendment”) is made and entered into as of January 1, 2021 (“Effective Date”), by and between **Aurora Health Care Metro, Inc.**, a Wisconsin non-stock corporation, **d/b/a Aurora St. Luke’s Medical Center School of Radiologic Technology** (“School”), and **Aurora Health Care, Inc.**, a Wisconsin non-stock corporation, contracting on behalf of certain of its affiliates (“Clinical Affiliate”).

**Recitals**

A. School and Clinical Affiliate are parties to that certain Student Clinical Placement Agreement dated August 27, 2014 (“Agreement”), pursuant to which Clinical Affiliate agreed to provide supervised clinical and educational experiences for students participating in School’s radiologic technology program.

B. The parties now wish to amend the Agreement in the manner set forth herein.

**NOW THEREFORE**, in consideration of the mutual promises herein contained, it is agreed as follows:

1. Term. As of the Effective Date, Section 5.1 of the Agreement shall be deleted and replaced in its entirety with the following:

“This Agreement shall be effective January 1, 2015 and continue for a term of five (5) years, ending December 31, 2020. Thereafter, this Agreement shall automatically renew for successive one (1) year terms, unless either party provides written notice to the other party of its intent to not renew the Agreement not less than thirty (30) days in advance of the expiration of the then-current term.”

2. Exhibit A. As of the Effective Date, the Exhibit A of the Agreement shall be deleted and replaced in its entirety with the Exhibit A attached to this Amendment.

3. Miscellaneous. Unless otherwise amended in this Amendment, the Agreement shall remain in full force and effect pursuant to the terms thereof. To the extent there is any conflict between this Amendment and the Agreement, this Amendment shall control. Any capitalized terms not defined in this Amendment shall have the meaning designated in the Agreement.
