Directions to Christ Medical Center


From the south: Take either Harlem Avenue, Cicero Avenue or Pulaski Road to 95th Street. From Harlem or Cicero proceed east on 95th to Kilbourn Ave and make a left. From Pulaski, travel west to Kilbourn Ave and make a right.

From the west: Take the Tri-State Tollway I-294 north or south and exit onto 95th Street. Follow 95th Street to Kilbourn Avenue and make a left.

From downtown Chicago: Take the Dan Ryan Expressway I-94 south to the 95th Street exit and go west. Or, take the Stevenson I-55 to Cicero Ave. Go south on Cicero to 95th Street, then east on 95th to Kilbourn and make a left.


From the north: Take the Kennedy Expressway I-90 downtown to the Dan Ryan Expressway I-94. Following the Dan Ryan south to the 95th Street exit and go west on 95th Street. Follow 95th Street west to Kilbourn and make a right.

From the northwest suburbs or O'Hare Airport: Take the Tri-State Tollway I-294 south and exit east on 95th Street. Follow 95th Street to Kilbourn Avenue and make a left.

Badges and Parking

Badges:


Parking:

STUDENT/FACULTY EXPECTATIONS & DRESS CODE

Follow policies and procedures of Advocate Aurora Health Care.
Protect Security of EMR password and patient health information.
Student Observations - Only 1 student per nursing area in one day is allowed. Jennifer Bak must be notified of scheduled observations of the students
Turn cell phones off while providing patient care.
Wear the Advocate Identification badge and School ID badge at chest level at all times. Badges MUST BE returned at end of clinical
Dress in a professional manner following the respective School of Nursing Uniform Policy and be clearly identified as a student nurse. Students should not wear green scrubs unless in surgery or providing obstetrical care.
Health Insurance Portability and Accountability Act (HIPAA) & Confidentiality o Ensure all patient specific information is kept private and confidential o Do not make copies or print from EMR
Be prepared to work in the clinical setting in a safe manner that demonstrates professional standards and behavior.
If a student becomes ill or is injured while in clinical a Rapid Response may be called, or they be taken to the emergency room for assessment/treatment. Emergency outpatient treatment will be available to students while in the hospital for clinical training, in case of accident or illness the hospital shall not bear the cost of the emergency treatment.

Electronic Medical Record Documentation and Access Guidelines



□ Epic access information

- Access will be coordinated by the Clinical Affiliations Coordinator and your school as appropriate, and instructions will be provided to your school.
- Students and faculty at each school are required to submit information in order to request access to the EPIC platform.
- A network user ID (AAH ID) is required to gain access to the EPIC application.
- If it is a NEW ID, an email will be sent to the student/faculty email address to sign the confidentiality statement and activate the account. This must be done before the user may login to EPIC.
- AAH ID and EPIC user ID Instructions: Read all directions carefully and follow specified instructions to either: Activate NEW ID per email received; Activate if no email received; Recover current AdvocateOne and Network ID; or Reset a current Advocate Aurora Network ID password.
- EPIC requires a password reset every 90 days. You may receive an email with a reminder.
