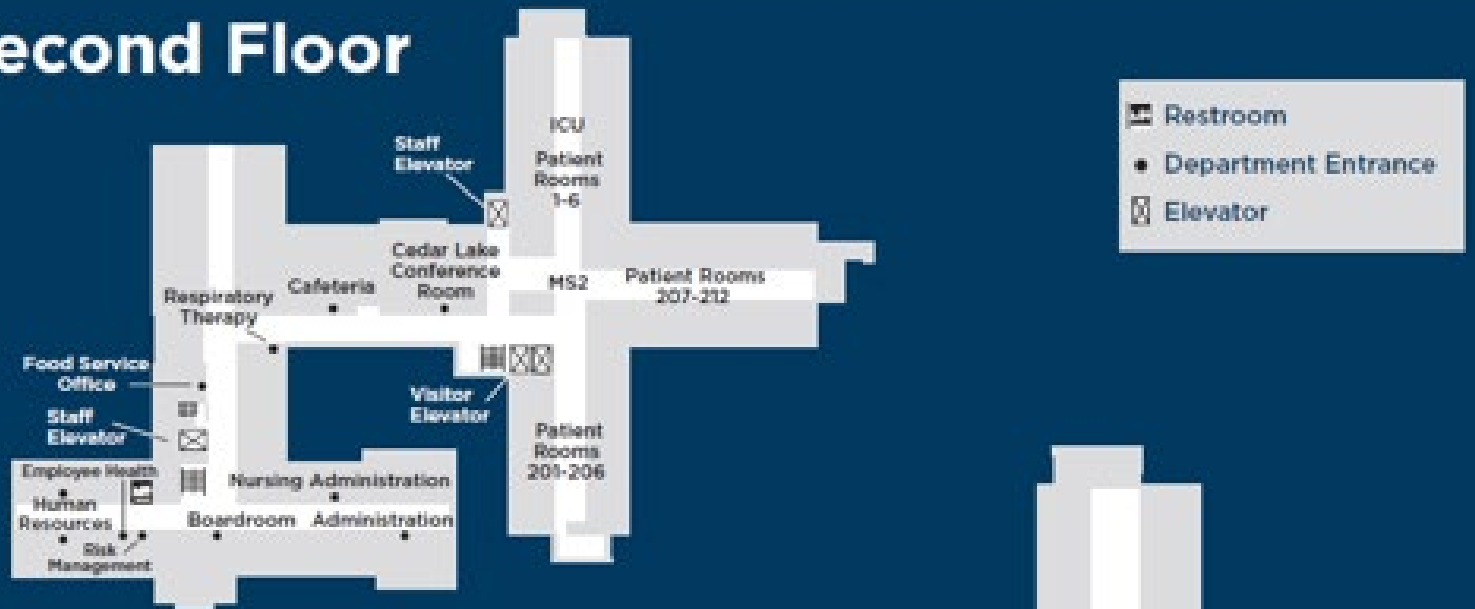

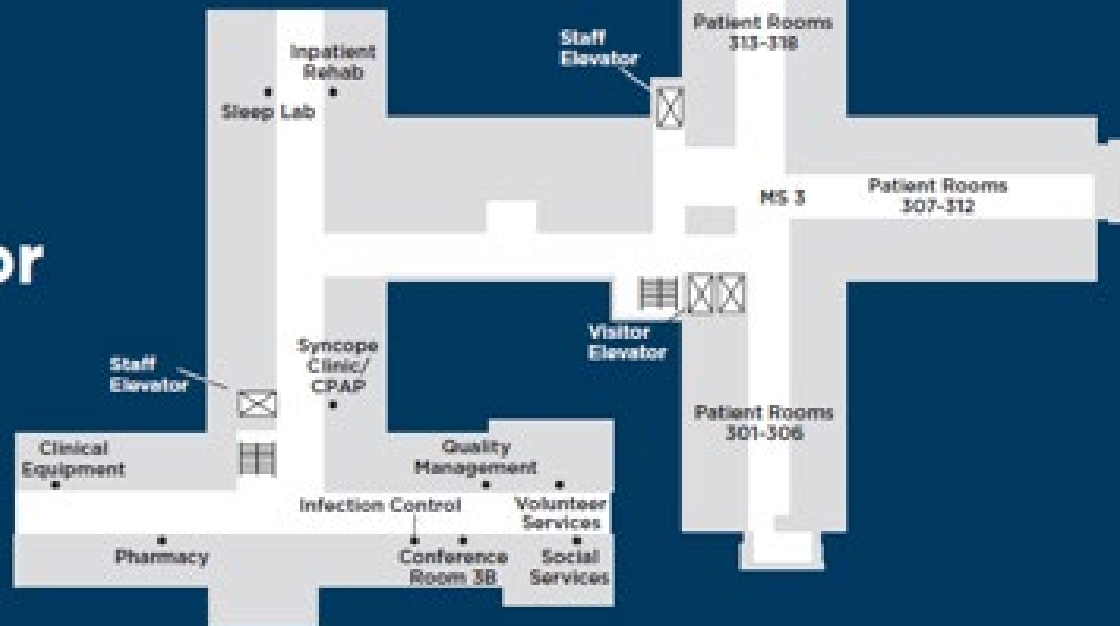

Other Clinical Experience Requirements

1. Badge Requests – Faculty Identification

- a. Students will wear their school-provided picture identification while on Aurora Medical Center Washington County property. ID badges will be worn above the waist while on Aurora Medical Center Washington County property. On-site clinical faculty will obtain an Aurora Medical Center Washington County ID badge from public safety prior to the beginning of their rotation.
- b. Nursing faculty must wear an Aurora issued Nursing Faculty badge; if you work in Aurora you cannot wear/use your teammate name badge.
- c. Send a JPG picture of yourself to [site school liaison](#) to obtain nursing faculty badge.
 1. Take photo with a plain background.
 2. Photo should include only head and shoulders.
 3. Verify photo is a JPG format and straight up and down.
- d. Always wear your badge above your waist, in a visible location.
- e. Instructor to send list of students to site school liaison to obtain access cards (if needed)

2. Cafeteria: located on 2nd floor and accepts cash or credit card. There is limited space in staff break rooms so please eat in the cafeteria or reserve a conference room.

- a. Cafeteria hours: 0700-0930, 1100-1330, 1700-1830
Grab and Go Options 0700-1830
- b. Off-shift options: unless you are an AAH team member and have set up dine and debit on your AAH employee ID badge, there are no available food options for students during the night shift except vending machines.
- c. Vending machines: accept cash or credit

3. Emergencies: push the staff assist or code button in patient rooms or dial x41 on any hospital phone.

4. Entrances: all students and clinical instructors will need to wear ID badges and complete the Safe Check app prior to arrival. Please establish a meeting area on day 1/orientation day (the main entrance is a typical meeting place). After that, clinical groups can choose to meet on the units at the start of their shift. Do not use the Surgery Center entrance.

5. Clinical cohort size is based on manager approval. Currently, due to unit size, we are limiting cohorts to 6-8 students on the unit at a time (depending on the unit). May have a larger student number enrolled, but only this number allowed on the unit at one time.

6. Clinical Workspaces:

- a. Computer classroom (4th floor) can be utilized for patient prep, if scheduled in advance or not in use. Door will need to be unlocked by Public Safety.
- b. Conference rooms can be requested for pre/post conference room, but due to site needs, these are not guaranteed. Contact the Clinical Affiliation Liaison (site contact).

7. **Off-Unit Experiences:** will be offered per instructor's requests, if possible

8. **Belongings:** limit any type of valuables as we have minimal space for storage on the units
